Shippers are responsible to track packages to ensure delivery has been made. At the conclusion of the conference, packages to be shipped from the I Hotel and Conference Center should have prepaid labels attached to each package and vendors should confirm that Fed Ex, UPS, etc. agrees to pick up the package based on the label provided. Vendors must bring the packages to the Conference Center desk and not leave them at their booth. For over-sized shipments that will arrive/depart by freight, vendor should contact the Conference Center to discuss size and weight. We do NOT have a lift gate. Trucks must arrive with their own lift gate. We have limited storage and over-sized deliveries should be discussed in advance and could incur a fee for storage.
